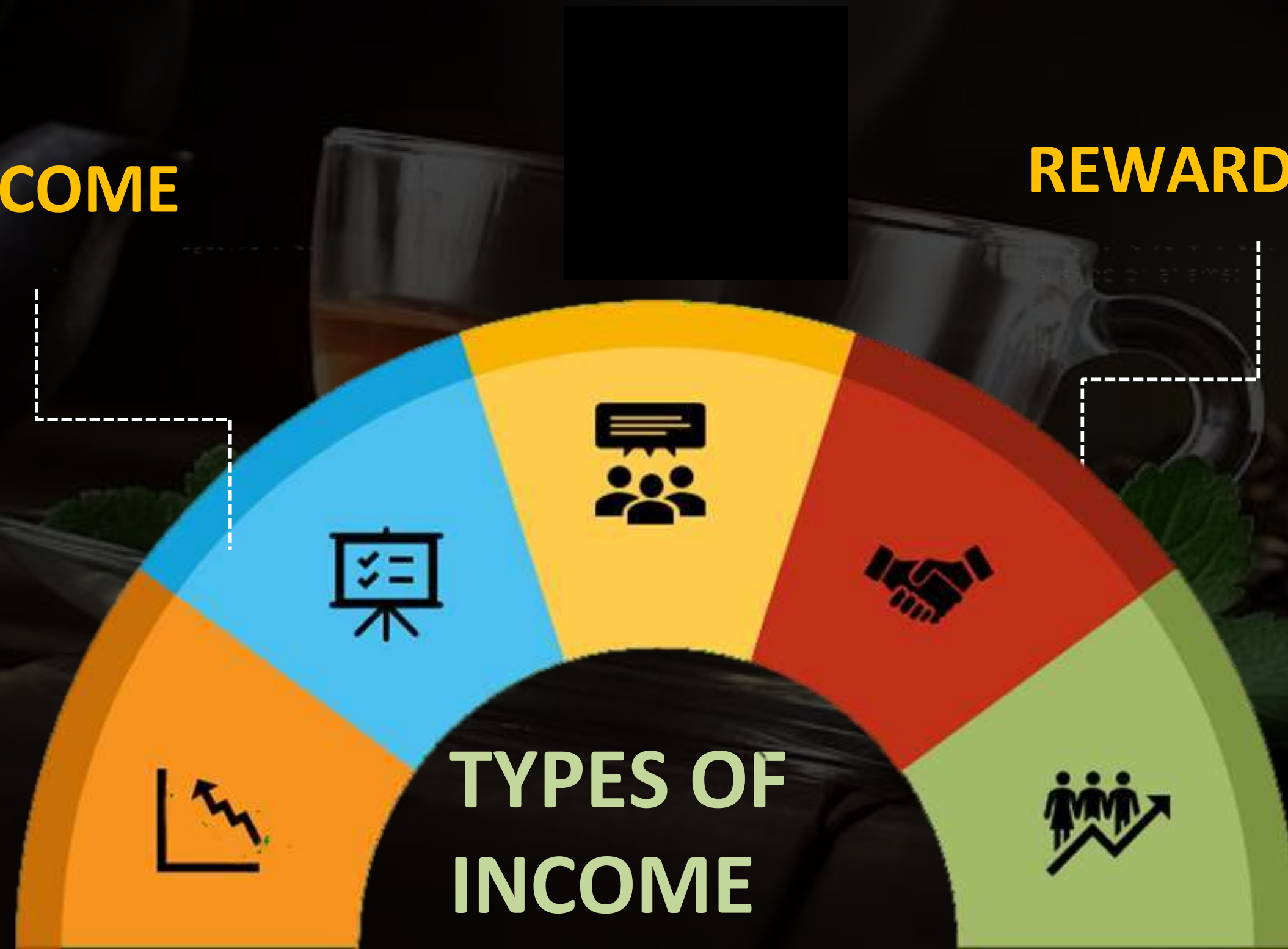

# REWARDS CONDITIONS

---



**Mandatory Monthly Repurchase:** Every member must complete a minimum monthly repurchase of 1500 to remain active and eligible for rewards, incentives, and rank benefits.

**Missing One Month Repurchase:** If a member fails to complete the required repurchase for one month, rewards for that month will not be calculated or credited.

**Missing Two Consecutive Months:** If repurchase is not maintained for two consecutive months, the member's ID will be kept on hold, and all reward benefits will remain suspended until activation.

**Missing Three Consecutive Months:** If repurchase is not maintained for three consecutive months, the member's ID will be permanently blocked, and reward eligibility will be cancelled.

**Active Status Requirement:** Rewards, incentives, leadership income, and rank recognition will be applicable only to active members maintaining the minimum ■1500 monthly repurchase

# Term & Condition

- Sponsors must guide and support newly joined members. False income promises, misleading promotions, or forced joining practices are strictly prohibited.
- Rewards are applicable only after achieving the required rank qualifications. Monthly maintenance must be completed. Company verification and audit may be conducted at any time.
- Products must be sold ethically. Selling below MRP (price dumping) is not allowed. Unauthorized online marketplace selling is strictly prohibited without company approval.
- In case of death or incapacity of a distributor, the registered nominee may continue the ID after legal verification and company approval.
- The company reserves the right to terminate any ID in cases of policy violation, fraudulent activities, brand misuse, or actions damaging company reputation.
- All decisions taken by Bongveda Wellness Pvt. Ltd. management shall be final and binding.
